This acceptable use policy sets out the terms between you and us under which you may access our website www.paymystaff.co.uk (**our site**). This acceptable use policy applies to all users of, and visitors to, our site.

SUSPENSION AND TERMINATION

We will determine, in our discretion, whether there has been a breach of this acceptable use policy through your use of our site. When a breach of this policy has occurred, we may take such action as we deem appropriate.

Failure to comply with this acceptable use policy constitutes a material breach of the terms of use (www.paymystaff.co.uk/terms) upon which you are permitted to use our site, and may result in our taking all or any of the following actions:

- Immediate, temporary or permanent withdrawal of your right to use our site.
